## Consent Agenda and Report of the Stated Clerk

#### **Motions from the Stated Clerk**

- 1. That Grace Presbytery receive the final report and dismiss the Administrative Commission for First Presbyterian Church of Ferris with gratitude.
  - A. At the request of the congregation, on February 24, 2021 Grace Presbytery Council elected the following as an Administrative Commission for **First Presbyterian Church**, **Ferris** with the authority to implement the Grace Presbytery Policy on Dissolving Congregations: **Rev. Thomas Gibbons** (H.R.) Moderator [added June 16, 2021], **Rev. Robert M. Young** (H.R.) [removed June 16, 2021], **Ruling Elder Patsy Chandler**,

(Ferris, First), **Ruling Elder Patty Dickerson** (Waxahachie, Central), **Ruling Elder Karen Ebling** (Grace Presbytery Director of Property Management), and **Rev. Craig Krueger** (Grace Presbytery Director of Ministry Transitions, Grace Presbytery and staff liaison).

- B. The Administrative Commission voted to dissolve the congregation of First Presbyterian Church, Ferris effective **April 4, 2021**.
- C. The Administrative Commission took the following actions, per the Grace Presbytery Policy on Dissolving Congregations:
  - 1) Completed an inventory of church building contents, boxed important papers and church records, and delivered these to the presbytery office.
  - 2) Accessed the church safe deposit box at Commercial State Bank, removed contents, and delivered the contents to the presbytery, and closed the account for the safe deposit box and was issued a rental refund.
  - Closed cash accounts at Commercial State Bank and at BBVA and transferred funds to the presbytery. Two Certificates of Deposit at BBVA matured and funds were transferred to the presbytery.
  - 4) Engaged Independence Title Company to do a title search for all real properties and to convey titles to Grace Presbytery. A general warranty deed was filed with Ellis County, Texas Clerk on August 20, 2021 for the following properties:
    - a. Church Building located at 201 N. Church St, Ferris, Texas 75125
      - Ellis County Property ID 193481, 0.2459 acres
      - Legal Description: Lots 1 & 2, Block 22, City of Ferris; Recorded in Volume Q, Page 197, Deed of Records, Ellis County Courthouse, Waxahachie, Texas.
    - b. Church Manse (residence) located at 408 S. Church Street, Ferris Texas 75125
      - Ellis County Property ID 193482, 0.2111 AC
      - Legal Description: South ½ of Lots 10, 11, 12 in Block 9, City of Ferris; Recorded in Volume 404, Page 515, Deed of Records, Ellis County Courthouse, Waxahachie, Texas.
  - 5) Initiated (at the request of church members) discussions with the City of Ferris regarding donation of the church building property to the city. This action and decision authority transferred to the Grace Presbytery Board of Trustees upon title conveyance.
  - 6) Signed a month-to-month lease between manse Tenant and Grace Presbytery as Landlord, with notice that we would list this property for sale and notified tenants that they should purchase renter's insurance under the terms of the lease. Responsibility for continued management of the lease and arrangement was transferred to the Grace Presbytery Board of Trustees upon title conveyance.
  - 7) Cancelled the current property and liability insurance coverage and added coverage for the church building and manse to Grace Presbytery's policy.
  - 8) Kept electric and water utilities at church building activated due to sump pump needed in the basement during heavy rains and changed billing responsibility for

- these utilities to Grace Presbytery and engaged a local lawn maintenance company to keep the grass mowed at the church property until further notice.
- 9) Removed all identifying church signs from property.
- 10) Researched and determined employment status of Mr. Jim Riley as a contracted church employee. Mr. Riley, who was not affiliated with Grace Presbytery, was hired and paid regularly as a supply preacher and custodian for many years. The Administrative Commission notified Mr. Riley of its intention to file Form 1099-MISC to the IRS for up to five years prior payments for preaching and custodial services. Rev. Polly Williams who also served the church received the same notice.
- 11) Issued a letter of notice to Mr. Steve Chapman, attorney for Virginia Duff Estate, regarding the closure of the church and therefore termination of the church as beneficiary of Exxon-Mobil stock dividends.
- 12) Filed with U.S. Post Office for all mail to be forwarded to the presbytery office.
- 13) Filed a nonprofit corporate dissolution form with Texas Secretary of State and received a response that this corporation does not exist, and subsequently determined it was previously removed from record due to failure to maintain status and pay filing fees.
- 14) Researched the Texas Unclaimed Property website and found none for this entity.
- 15) Acknowledged that some church members requested a donation of \$50,000 to be sent to Mo Ranch from final proceeds of bank accounts and deferred this decision to the Grace Presbytery Council for consideration as presbytery policy states all proceeds of closed churches are deposited to the Presbytery Mission Budget Fund.
- 16) Fulfilled all other tasks required by the presbytery Policy on Dissolving Congregations.

## Brief History of First Presbyterian Church, Ferris

In 1858, the First Presbyterian Church was organized with 13 members and worshipped for a while in the Bear Creek school house. Then a log house was built about two miles west of Ferris.

In 1875 they moved to Ferris, and a frame building erected on the present property was used until it was destroyed by a spring storm in 1890. As soon as possible, another frame building was erected and used until 1925 when the present brick structure was erected under the pastorate of the late Dr. L. B. Gray. The present building was built in 1925-1926. Its Classical Revival design features paired plasters, a 3-bay primary façade with a founded arched entry, classical columns, and 2-story-stained glass windows.

In 1906, the congregation went into union with the Presbyterian Church (USA) and in 1910 merged with Southern Presbyterian Church of Ferris. In November 1945, the church treasurer announced that the loan on the building had been paid and the mortgage was burned. In 1971, the first evangelistic meeting was held with a total of 40 received into the congregation; 25 by baptism and 15 by letter. The church grew to a membership of 132.

During a history of more than 180 years, the congregation of First Presbyterian Church dedicated four church buildings "to the glory of God."

  - A. On November 18, 2020 Presbytery Council elected the following as an Administrative Commission to finalize the sale of the John Knox Presbyterian Church, Fort Worth facility including resolution of any deed issues related to the property: Ruling Elder Frank Stevenson (Dallas, Northridge) as Moderator, Ruling Elder Kevin Green (Dallas, Preston Hollow), Ruling Elder Jefferson Howeth (Dallas, NorthPark), Ruling Elder Karen Ebling (Richardson, Canyon Creek), and Rev. Michael Thompson (Interim General Presbyter. [11-18-20]
  - B. An earlier Administrative Commission for John Knox Presbyterian Church was elected to dissolve the congregation which took place on **April 3, 2016**. This is the second Administrative Commission for John Knox Presbyterian Church elected for the sole purpose of selling the property which took place in 2021.
- 3. That Grace Presbytery receive the final report and dismiss the Administrative Commission for First Presbyterian Church, Troup with gratitude.
  - A. At the request of the congregation, on June 12, 2020 Grace Presbytery Council elected the following as an Administrative Commission for **First Presbyterian Church**, **Troup Rev. Stuart Baskin** (First Presbyterian Church, Tyler), Moderator, **Ruling Elder Kelly Weaver** (First Presbyterian Church, Henderson), **Ruling Elder Karen Ebling** (Grace Presbytery staff), and **Ruling Elder Jimmy Chapman** (First Presbyterian Church, Henderson) with the authority to dissolve the congregation.
  - B. The Administrative Commission voted to dissolve the congregation effective **November 15, 2021.**
  - C. The Administrative Commission took the following actions:
    - 1) Closed the bank account at Austin Bank of Troup and transferred the amount remaining in the account (over \$17,000) to Grace Presbytery. (11-15-21)
    - 2) There were two checks which the church treasurer had previously written which had not yet cleared the bank. The exact amount of money to cover those checks was left in the bank. When those checks have been paid, the account will automatically close. (11-15-21)
    - 3) The safe deposit box at the bank had already been closed.
    - 4) Closed the post office box and filled out a change of address form so that any future bills will come to the Grace Presbytery office. (11-15-21)
    - 5) Examined the files in the church file cabinet to find all documents that needed to be sent to the presbytery. All known documents have been turned over to Grace Presbytery.
    - 6) The utility bill has been transferred to Grace Presbytery.
    - 7) The church insurance has been transferred to Grace Presbytery.

- 8) The lawn care bill from New Creation, a local lawn care service, has been transferred to Grace Presbytery.
- 9) A local cleaning service run by Talio Saso, cleans the church about twice a month. Its bill has been transferred to Grace Presbytery.
- 10) The church property has been transferred to Grace Presbytery.

## Brief History of First Presbyterian Church, Troup

The Rev. W. W. Brimm of Tyler began conducting Presbyterian worship services in Troup, Texas in 1873, soon after the town of Troup was platted along a line of the Houston and Great Northern Railroad. Under his direction, this church was organized that same year with eight charter members. The first ruling elder was Colonel Thomas W. Bell (1802-1876), who moved to Texas from Tennessee in 1849. After settling in Canton (now Omen) where he owned a hotel, he moved to Troup. A charter member of the First Presbyterian Church he was instrumental in the early development of the congregation.

Services were moved to the current site from a temporary sanctuary in 1876, when trustees acquired the land from the railroad company. A building here served the congregation until 1909 when a new structure was completed. During construction of the facility, services were held in the local Masonic Lodge Hall.

For over a century the First Presbyterian Church of Troup has been active in the development of the community. Many pioneer area settlers and early civic leaders were members here. Part-time pastors have included several seminary students who later became prominent Presbyterian leaders.

- 4. That Grace Presbytery receive the final report and dismiss the Administrative Commission for Milford Presbyterian Church, Milford with gratitude.
  - A. At the request of the congregation, on February 21, 2022 Grace Presbytery Council elected the following as an Administrative Commission for **Milford Presbyterian** Church, **Milford** with the authority to implement the Grace Presbytery Policy on Dissolving Congregations: **Rev. James Ellor** Moderator, **Rev. Stephen Rehrig**, **Ruling Elder Maurine Powell**, (Milford PC), **Ruling Elder Patty Dickerson** (Waxahachie, Central) and **Ruling Elder Karen Ebling** (Grace Presbytery Director of Property Management).
  - B. The Administrative Commission voted to dissolve the congregation of Milford Presbyterian Church, Milford effective **April 17, 2022**.
  - C. The Administrative Commission took the following actions, per the Grace Presbytery Policy on Dissolving Congregations:
    - 1) Completed an inventory of church building contents, boxed important papers and church records, and delivered these to the presbytery office.

- 2) Closed cash accounts at First State Bank, Italy (checking, session and money market accounts) and transferred funds to the presbytery.
- 3) Deeds and title opinions were delivered to the presbytery for the property located at 300 S. Main, Milford, Texas.
- 4) Initiated (at the request of church members) discussions regarding the sale/donation of the church building property. This action and decision authority transferred to the Grace Presbytery Board of Trustees upon title conveyance.
- 5) Cancelled the current property and liability insurance coverage and added coverage for the church building and manse to Grace Presbytery's policy.
- 6) Terminated water, gas utilities at church building and transferred electric account to the presbytery for handling. Engaged a local lawn maintenance provider to keep the grass mowed at the church property until further notice along with retaining the church cleaning crew for once/month cleaning until further notice.
- 7) Removed all identifying church signs from property.
- 8) Filed with U.S. Post Office for all mail to be forwarded to the presbytery office.
- 9) Filed a nonprofit corporate dissolution form with Texas Secretary of State on April 18, 2022.
- 10) Researched the Texas Unclaimed Property website and found none for this entity.
- 11) Acknowledged that some church members requested a donation to be sent to Presbyterian Children's Home Itasca from final proceeds of bank accounts and deferred this decision to the Grace Presbytery Council for consideration as presbytery policy states all proceeds of closed churches are deposited to the Presbytery Mission Budget Fund.
- 12) Dialogue with local family involved in the transportation of the church's bells about their extracting the bells for personal display. However, family determined that the cost of extraction was too high, so have backed out of the discussion. They would however, like to be notified if it is determined that the building will be torn down.
- 13) Fulfilled all other tasks required by the presbytery Policy on Dissolving Congregations.

#### Brief History of Milford Presbyterian Church, Milford

The church was organized in June 1855 with 16 members as only one of four Presbyterian churches within a radius of 500 miles of Milford. Horseback-traveling pastors organized and served three churches in outlying areas.

The congregation built houses of worship in 1860, 1896, and 1921. The church was host to the presbytery four times during 1861-1871. It hosted the synod in 1920.

Milford has been faithful in support of Presbyterian colleges of Texas. The church bell was cast in New York and brought here by ship, rail, and ox-wagon. It began calling the area to worship in 1871.

5. That Grace Presbytery dissolve the congregation of New Shamrock Presbyterian Church of Clarksville, Texas effective September 22, 2022 at the request of the session.

- A. The session has requested the dissolution of the congregation.
- B. On November 14, 2009 the presbytery permitted the church to convey its real property by deed to the New Shamrock Cemetery Association. Currently there is no property owned by the congregation.
- C. Historical material about the church was included in the November 14, 2009 report of the Administrative Commission for **New Shamrock Presbyterian Church,** Clarksville.

- 1. That Grace Presbytery approve the following change in Standing Rule 2.1.3 (new text is indicated in bold italic font):
  - 2.1.3. Commissioners at presbytery meetings with voice and vote include ... Ruling elder Certified Christian Educators and Certified Associate Christian Educators during their term of service in an educational ministry under the jurisdiction of Grace Presbytery, Synod of the Sun, the General Assembly, or a ministry approved by the Committee on Ministry of Grace Presbytery but are not otherwise elected as a commissioner from a session.
- 2. That Grace Presbytery approve the following changes in Standing Rules 5.14.2. and 5.14.4. (new text is indicated in bold italic font):
  - 5.14.2. Administrative commissions are composed of ruling elders and ministers of Word and Sacrament in numbers as nearly equal as possible and sufficient to accomplish their work. All administrative commissions shall elect from their own membership a moderator and clerk.

- 5.14.4. Four Regional Administrative Commissions for the purpose of dissolving congregations consist of nine persons each nominated by the Nominating Committee and elected by the presbytery with members divided into three-year staggered terms. The General Presbyter (or designee) is an ex-officio member with voice and vote in each Regional Administrative Commission. The Four Regional Administrative Commissions are responsible for the implementation of the presbytery Policy on Dissolving Congregations within their region *or may elect other administrative commissions from within their region to fulfill this purpose*. Ordinarily, these commissions will not initiate the dissolution of a congregation without such a request voted by the session or congregation of the church.
- 3. That Grace Presbytery suspend Standing Rules 1.4.5 and 1.4.10 in order to approve the following changes in the presbytery meetings for 2023:
  - A. That two hybrid stated meetings be held next year on dates previously approved (February 25, 2023, at **Trinity Presbyterian Church, McKinney** and September 23, 2023, at **Preston Hollow Presbyterian Church, Dallas**). These two meetings will also be live-streamed.

#### **Motions from the Examinations Committee**

#### 1. That Grace Presbytery sustain the ordination examination of Parker Lucas.

Parker Lucas is currently serving as a Pastoral Resident for **First Presbyterian Church**, **Waco**. His home church is Spring Valley Presbyterian Church in **Trinity Presbytery**. Parker received his bachelor's degree in religious studies from University of South Carolina in Columbia in 2016. In 2021 he received his Master of Divinity degree at Austin Presbyterian Theological Seminary. He enjoys outdoor activities, working out, watching movies, reading poetry, playing board games, and creating art. His support system includes his wife Michelle, his parents Doug and Anna as well as his sister and brother-in-law Taylor and Michel and his niece Blythe.

Statement of Faith: I believe in a Creator God whose image we carry and who cares about the rugged human experience. Our experience is hope-filled but mired with fractured systems that constrict our created goodness. The Spirit draws out longing for that goodness, which is continually interrupted because of the rough terrain. Amid that terrain, the Creator descends in Christ to meet us, redeeming our lives and illumining our relationship to God, which is the Good News of the Gospel. The Gospel beckons the Church to be active in God's ongoing work in the world, wherein individuals and community's journey through the valleys and peaks of their lives. Along that journey, we can be in awe of the splendor of the Creator and seek to reflect the light of God for others. In these ways, we feel the deep investment of the Creator in the universe.

The Incarnate God, Jesus Christ, came to dwell in creation's midst, fully human and divine. Christ's incarnation, death, and resurrection affirm the goodness of creation and loosen the grip of sin. The resurrection reveals that humanity is grafted into God's ongoing redemptive work towards a return to how God made and intended creation to be. Christ shows that the Kingdom of God is present but not yet. In the present, the Church has the privilege to bear witness to God's unearned grace and love as it stewards the Sacraments. Christ initiated the Sacraments as a gift. We respond to God's grace and covenant with all creation in our participation. Baptism is a visible sign of God claiming, cleansing, and connecting us with God's ongoing creative process. In Communion, we approach a sustaining table, which nourishes, renews, and sends the church out into the world. Spirit-inspired scriptures of Old

and New Testament, prayerfully preached, illumine communities to bear witness to God's relationship to the world through conflict and covenant. The sacraments and scriptures bridge past, present, and future in sacred moments affirming the Spirit's movement and union with God.

I believe in a triune God of one substance consisting of three mutually dependent persons. Even in distinction, they are inseparable from one another; the Creator, Redeemer, and Spirit. Our Three-In-One God models a community holding space for God's redemptive work wherein we become active participants in God's ongoing creation and transformation towards God's intention for us, to love God and creation as God has loved us.

In the transformation of our minds, human beings are not required, but God empowers us to co-create. Possibilities to co-create arrive in our senses, which are portals of participation. Our eyes see the struggles of our neighbors. Our ears hear their cries and joys. Our mouths can speak words of kindness, and our hands can reach out in support of another. Our senses cue our participation in the Kingdom of God that is now and not yet.

#### 2. That Grace Presbytery sustain the ordination examination of Peter Manning.

Peter Manning is currently serving as the Blair Monie Resident at **Preston Hollow Presbyterian Church, Dallas**. His home church is Brick Presbyterian Church in New York Presbytery. He received his bachelor's degree in agriculture in 2004 at Columbia University in New York. In May of this year, he received his Master of Divinity degree from Princeton Theological Seminary in Princeton, NJ. He enjoys cooking, reading, and hiking. Peter has a daughter Katie Bishop-Manning 24.

Statement of Faith: I believe that God is revealed to us in three persons, the Father, Son, and Holy Spirit. This is revealed to us in scriptures which are divinely inspired, compiled by human beings with faith and have been explicated to us by a cloud of witnesses over millennia and require our constant, ongoing, and prayerfully diligent attention and inquiry. I believe Jesus Christ's life, death and resurrection is God's inbreaking, world shattering, self-revelation to us. At Pentecost the Holy Spirit is revealed as God with us in and through all things. We are called as followers of Jesus Christ to live a life modeled on him and to seek God continually and to do so in love through, prayer, worship, and service to our families, our communities, and the world. With the help of the Holy Spirit, and through prayer and the reading and proclaiming of scripture, on our own and in community, we discern how the perichoresis of the Holy Trinity is operating in and through and around us in all time and in all places.

One of the paradoxes of our faith is that Jesus the Christ has come and is coming. We experience the Kingdom of God in the here and now, but because of our brokenness it is often only in glimpses of transcendent love and service. However, we trust that in the fullness of time the Kingdom will come. The other paradox of our faith is the radical inclusivity of Jesus and the invitation to all to follow him, and the challenge that Scripture tells us that not all will be chosen. We live in this tension, trusting in God's ultimate, unchanging, and sublime love and forgiveness. Because we also know that in Jesus's atoning

sacrifice on the cross, he has reconciled all things in and through himself and to God so that we might live lives of justice, mercy and love.

Faith seeking understanding aptly describes the working out of my own faith. I do not ever remember not believing in God but as I have lived out a life of faith in my adult life, I have sought to understand more deeply what the grace of justification means for me. I believe that we are justified by faith and the gift of justification leads us to a process of sanctification and to vocation. Through this process of sanctification, and by living out the life we are called into by Jesus Christ, we find ourselves maturing as hearers of Scripture, maturing in prayer, in freedom, and in solidarity with creation and all of humanity, as well as growing in gratefulness, joy and hope. Sanctification is a process by which we grow in Christian love and in so doing become more holy. As Karl Barth says, "justification is the basis and presupposition of sanctification; sanctification is the aim and consequence of justification." Living into the grace that God so freely gives means we must die to an old way of life and live into a new reality. It is not easy. Sin is ever at our doorstep. Living into a life in Christ requires enormous sacrifice but also promises abundant life. When we turn to God we are continually forgiven for our sins and know that we are God's beloved and made in God's image

I believe the Church, reformed and always reforming according to the word of God given to us in Scripture, is the platform for the reconciled and redeemed community of Christ to come together and be reconciled to God and to each other through the ongoing work of Jesus Christ. Church is where the work of God can take place and from where we are sent to do mission in the world. The Church is the missional community where the sacrament of baptism and the eucharist take place. These sacraments are the outward signs which convey the grace of God and promises of the Gospel, and they connect us to Christ through the Holy Spirit. At baptism we are sealed into the life of the Church and to the body of Christ. The Lord's Supper sustains us by sharing in the life in Christ through the same grace bestowed on us in Baptism. Christ is present at the Eucharist by the power of the Holy Spirit to those who receive the elements in faith.

#### 3. That Grace Presbytery sustain the ordination examination of Claude (Wilson) Nicholson.

Wilson is currently serving at **Grace Presbyterian Church, Plano** as Director of Adult Discipleship and Nurture. and cognate in International and Cultural Diversity from Texas A&M University in 2011. <u>Statement of Faith</u>: God, creator of all, made us in God's image and has called us into a life of service, through the guidance of the Holy Spirit, by participating in the mission of Jesus Christ.

We have been called to put the teachings of Jesus into practice, as the hands and feet of Christ, by the power of the sustaining Spirit, through sharing God's peace, grace, and love with all.

In Baptism, we are claimed and loved by God as we bear witness to our dying and rising with Jesus, and incorporation into the Body of Christ. We proclaim God's grace and call to faithfully respond. As we are all offered the gift of living water, God also invites each one of us to Table to partake in an abundant feast. In the Eucharist, we commune with the crucified and risen Lord as well as all members of the Church in every time and place, while giving thanks for God's provision. At Table, through the Holy Spirit, our collective body is renewed, and we are reenergized to use the gifts God has given us to serve others. Though each individual's gifts are unique, we are equally called to participate in the mission of Jesus Christ by ministering to and loving our neighbors in the world.

The triune God creates, redeems, sustains, rules, and transforms all things and people. As Christians, with Christ as our example, we place our hope in the reality that death does not have the final say. We are an Easter people, who boldly proclaim belief in resurrection;

maintaining the hope that one day every tear will be wiped away and death no longer holds ultimate power.

#### **Meeting Cancellation Policy**

If a meeting needs to be cancelled or delayed for any reason, it will be announced on the Grace Presbytery website (<a href="www.gracepresbytery.org">www.gracepresbytery.org</a>). Also, the outgoing voice mail message for the Grace Presbytery main phone number (214-630-4502 or 800-678-4502) will provide up-to-date information about meeting cancellation or delayed start times.

The decision to cancel or delay the start of a presbytery meeting will be at the discretion of the Moderator of the Presbytery, in consultation with the General Presbyter and Stated Clerk of the Presbytery. Rescheduling a cancelled meeting of the Presbytery is the responsibility of the Moderator of the Presbytery.

#### **Parliamentary Procedure**

Parliamentary procedure enables the presbytery to become a deliberative assembly, to seek the will of God and to witness to our faith in Jesus Christ. It is never an end in itself. Parliamentary gamesmanship is never appropriate.

The will of the majority shall prevail, but the rights of the minority shall always be protected. Parliamentary principles balance individual conscience with the will of the majority. It takes seriously the following rights of individual members: (1) the right to know (due notice); (2) the right to speak (rules of debate); (3) the right to vote (membership); and (4) the right to hold office (fair representation). The Moderator represents the unity of the body. The Moderator preserves decorum and protects the rights listed above.

If you wish to speak, stand, and move to a microphone (if you are a commissioner participating in person). If you are a commissioner participating electronically, use the computer program to ask to be recognized. The moderator must recognize all speakers before they can speak.

Parliamentary procedure allows discussion of a subject only when a motion about that subject has been made. To speak during the meeting, please ask to be recognized. When recognized by the Moderator, state your name, church, city, and status – such as ruling elder or Honorably Retired. You may speak to a pending motion or ask a question. The person making a motion will have first opportunity to speak to the motion. Only motions coming from individuals need a second. A motion made on behalf of a committee already has a second: the majority vote of the committee.

Only commissioners may speak and vote on motions. You should speak only once on a subject, but you may seek to speak a second time only after everyone who wishes to speak has spoken. All remarks during debate shall be addressed to the Moderator. Questions seeking information from a person who has the floor shall be addressed to the Moderator. Speeches to an individual or the whole presbytery are not permitted during debate. Reading reports or documents out loud requires the permission of the presbytery. In debate, remarks shall be confined to the pending motion. Remarks shall not impugn another commissioner or that person's motives. Names of commissioners shall not be used.

To end debate, a commissioner must seek to be recognized, when recognized by the Moderator, state: "I move the previous question." It is not appropriate to call the question without being recognized.

If you offer a substitute motion or a new item of business, you should give the Stated Clerk advance notice and a written copy via email or hand delivered note. (An electronic copy is preferred.) This will help the Moderator and Stated Clerk facilitate the work of presbytery. The Stated Clerk is available to help suggestions as to how and when it would be appropriate to make the motion. The Stated Clerk is available to advise commissioners on the wording of any motion so that it can clearly express the concerns of the commissioner. When in doubt, ask. The Moderator and the Stated Clerk are eager to help you understand and use the process.

#### **Persons Entitled to Vote**

- 1. All ministers of Word and Sacrament on the Teaching Elder Roll of Grace Presbytery.
- 2. All ruling elders elected by sessions in accordance with the formula approved by Grace Presbytery and the Standing Rules. (Questions concerning the number of elders permitted for each congregation should be directed to the Stated Clerk.)
- 3. Certified Christian Educators who are ruling elders but are not otherwise commissioned by their sessions during the term of service in an educational ministry under the jurisdiction of the presbytery.
- 4. Certified Associate Christian Educators who are ruling elders but are not otherwise commissioned by their sessions during the term of service in an educational ministry under the jurisdiction of the presbytery.
- 5. Ruling elders, not elected by their sessions, who are serving as elected members on these Presbytery entities: Presbytery Council, Committee on Ministry, Committee on Preparation for Ministry, Permanent Judicial Commission, Committee on Representation, Nominating Committee, Administrative Commission on Property, Board of Trustees, Personnel Committee, Budget and Finance Committee, Youth Ministry Committee, Young Adult Ministry Committee, New Church Development Committee, Congregational Support Committee, and Administrative Commissions.
- 6. Ruling elder commissioners to the last General Assembly.
- 7 Commissioned Pastors not otherwise elected from their sessions

#### Persons Entitled to Speak but Not Vote

- 1. Christian educators employed by churches of Grace Presbytery who are not certified and are not ruling elders.
- 2. Ruling elders elected from a new church development Steering Committee of Grace Presbytery.
- 3. Corresponding members (ministers of Word and Sacraments and ruling elders from other presbyteries or denominations) when received by the presbytery.
- 4. Representatives elected by the congregations of churches in covenant relationship with Grace Presbytery when approved by the presbytery.
