- 1. Referred the motion to receive the Report of the Task Force for Congregational Support to Budget and Finance Committee for further study. Budget and Finance Committee will submit a report to the next Stated Meeting of Presbytery Council. Note: Next Stated Meeting of Presbytery Council is April 16, 2023. [2/1/23]
- 2. Motion to refer to Board of Trustees Investment subgroup in consultation with Budget and Finance Committee to develop a loan and oversight of loan to Kin\*dom Community to repay their debt to Trinity McKinney of \$61,000. An immediate payment of \$61,000 be made to Trinity, McKinney by the Board of Trustees. [2/1/23]

# 3. That Grace Presbytery approve the following actions taken by the Presbytery Council in accordance with the authority delegated by the Standing Rules and Manual of Administrative Operations and receive the items of information. [2/1/23]

A. Appointed the following people in accordance with Standing Rule 4.2.21 and Standing Rule 5.1 to the positions indicated. Note: An opportunity for nominations from the floor was afforded prior to the appointment.

Children and Youth Ministry Committee Co-Moderator and Council Representative: Rev. Eric Peterson (Temple, Grace)

- B. Approved the Stated meeting of Council minutes from October 19, 2022 and the Called Meetings of Council on November 16, 2022 and January 3, 2023.
- C. Approved the minutes of the Stated Presbytery meeting on November 12, 2022 and the Called Meeting of Grace Presbytery on January 21, 2023.
- D. Approved the motion to elect two Presbytery Council members to the Synod of the Sun Executive Search Committee. Nominations from the floor were taken. The elected Council members to serve on the Synod of the Sun Executive Search Committee are **Ruling Elder Chip Black** and **Rev. Elizabeth Landes**.
- E. Referred the following motion: approve the organizational plan moving forward by developing a staffing model with four (4) regional Pastor to Church Leaders in Grace Presbytery. The search and election for the Pastor to Church Leader positions will follow the election of the General Presbyter to a group consisting of the Personnel Committee, Stated Clerk, General Presbyter, Representatives of the Vision team, Representatives from the Budget and Finance Committee, in consultation with the current staff, to recharacterize the staffing model for living into the vision for Grace Presbytery and submit a proposal back to Council.

- a. Presbytery Council tabled the above motion on October 19, 2022 to the next stated meeting of Council. The February 2, 2023 meeting was the next stated meeting of Council.
- b. Motion was made to enter Executive Session at 11:20 am.
- c. Motion was made to rise from Executive Session at 11:58 am.
- d. Motion was made to refer by Rev. Dr. Ronnie Holloman and seconded by Rev. Dr. Lander Bethel. Motion to refer passes unanimously.
- F. Approved to renew annually a \$3,600 grant from the Mission Outreach Fund (55600) for the Thai Fellowship/Trinity Presbyterian Church Mansfield until such time the Committee on Ministry recommends a change. (Note: COM will engage the leadership of the Thai Fellowship/Trinity Mansfield in an annual review of the status of the ministry and mission needs.)
- G. Approved that members of the Social Justice Task Force (SJTF) who are volunteer deputy voter registrars in the appropriate jurisdictions to provide information and enroll people to vote at venues such as presbytery meetings and church gatherings, when invited and appropriate.
  - a. <u>Background</u>: Voting access is a justice issue for those who face obstacles in registering. The SJTF believes to it necessary to provide as many opportunities as possible for people to register, especially during less anxious periods (between elections, for instance) to avoid any undue semblance of partisanship. There will be absolutely no pressure placed on anyone to register, only to provide information and opportunity. According to county elections requirements, one can become a Volunteer Deputy Voter Registrar (DVR) by going through county training and accreditation. After that, a DVR may function in an official capacity not simply to hand out voter registration cards, but to actually receive those completed cards on behalf of their county of residence. The DVR is legally obligated to deliver the completed forms to the proper county elections administrator for proper processing under penalty of law. The SJTF acknowledges that while it is likely that a majority of the presbytery members are already registered, it would be helpful to model registration efforts, especially when viewed as a justice issue.
- H. Approved a motion to donate \$50,000 from First Presbyterian Church Ferris final proceeds as a one-time contribution to Mo-Ranch's Capital Campaign.
  - 1. The final report from the Administrative Commission for First, Ferris acknowledged that some church members requested a donation of \$50,000 to be sent to Mo Ranch from final proceeds of bank accounts and deferred this decision to the Grace Presbytery Council for consideration as presbytery

policy states all proceeds of closed churches are deposited to the Presbytery Mission Budget Fund.

- I. Referred a letter received from Mo-Ranch to Council to support their capital campaign with a three-year contribution to the Children and Youth Ministry Committee.
- J. Received a report from the Committee on Representation Moderator Crysta Brantley.
- K. Received a report from the Congregational Support Committee Moderator Rev. Lander Bethel.
- L. Received a report from Property Ruling Elder Karen Ebling.

- B. COR will continue the regional visits begun in 2022, accompanied by the Social Justice Task Force. In 2022, meetings were held with church leaders in the South and East regions of the presbytery. On April 15, 2023, COR and SJTF will visit the West region with a gathering at Gethsemane Presbyterian Church in Fort Worth at the invitation of the Rev. Jess Gonzalez. #### <u>Final Report</u> Administrative Commission for St. Luke Presbyterian Church, Dallas, TX <u>02/23/2023</u>

Motions from the Administrative Commission for St. Luke Presbyterian Church, Dallas, TX

- 1. That Grace Presbytery receive this final report and dismiss the Administrative Commission for St. Luke Presbyterian Church of Dallas, TX with gratitude.
  - A. The Presbytery Council elected **Reverend Kelly Yeager** (First Presbyterian Church, Allen) Moderator, **Ruling Elder Lillie Frisby** (St. Luke Dallas), **Ruling Elder John Gifford** (Canyon Creek Presbyterian Church, Richardson), **Reverend Ken Ritchie** (Faith Presbyterian Church, Farmers Branch), **Ruling Elder Margaret Rogers** (First Presbyterian Church, Richardson) and **Ruling Elder Karen Ebling** (Grace Presbytery Staff) as an Administrative Commission with the authority to dissolve the St. Luke Presbyterian Church, Dallas, TX, congregation.
  - B. The Administrative Commission voted to dissolve the congregation of St. Luke Presbyterian Church, Dallas, TX, effective September 19, 2022.
  - C. The Administrative Commission took the following actions:
    - 1) The Administrative Commission sent a letter to the Session of St. Luke Presbyterian Church of Dallas, TX in early April, 2022, informing them of the dissolution, asking for their preference for a final worship date and informing them that the Administrative Commission would assist in finding new church homes for St. Luke members.
    - 2) The Administrative Commission set the date of the final worship service for September 18, 2022.
    - 3) The Administrative Commission agreed that books from the St. Luke library may be donated to Glendale Presbyterian Church.

- 4) The Administrative Commission agreed that members who donated Bibles and hymnals may take the Bibles and hymnal they donated and that any remaining Bibles and hymnals may be donated to Glendale Presbyterian Church
- 5) The Administrative Commission transferred responsibility for the sale of the church property at 5915 Singing Hills Drive, Dallas TX 75241, to Grace Presbytery.
- 6) The Administrative Commission determined that Grace Presbytery owns the manse property at 5919 Singing Hills Drive, Dallas TX 75241. The property was owned by The Presbytery of the Trinity, which was merged into Grace Presbytery in 1978, and title was never transferred to the local congregation. A tenant currently resides in the manse property and is referred to the Board of Trustees for action.
- 7) The church checking account at Wells Fargo Bank was closed on December 20, 2022, and the remaining balance of \$3,308.59 was transferred to Grace Presbytery.
- 8) Confirmed that website and social media accounts belonging to St. Luke Presbyterian Church were closed and deleted and that the St. Luke Facebook page was no longer active.
- 9) All known St. Luke Presbyterian Church of Dallas, TX, church records and documents have been gathered, inventoried and delivered to the presbytery office for shipping to the Presbyterian Historical Society.
- 10) All utilities have been transferred to Grace Presbytery.

## Brief History of St. Luke Presbyterian Church, Dallas, TX

St. Luke Presbyterian Church was organized under Grace Presbytery's new church development and was established on September 28, 1958. The St. Luke Session and board of Deacons were created in December, 1959. The first official session meeting was held January 2, 1960. There were no women on any of these committees.

The first pastor was Howard Childers who came to the church in September, 1962, and resigned in June, 1966. Robert Coffman came to St Luke as pastor in September, 1966. When Rob came to St. Luke, racial change was taking place in the US, and the area where the church is located was no exception. Rapid white flight began and approximately 90% of the membership was gone by 1966 with only 40 members left on the role. In order to salvage what was left at St. Luke, Robert Coffman sent out a letter with the "Blessings" of the National Mission Committee to various Presbyterian Churches in the Dallas area for their assistance. White members were asked

to move their memberships to St. Luke, for at least three years. Some white members stayed for as long as 12 years. By 1971, under the leadership of Robert Coffman, St. Luke's membership had grown to 114 members of which 60% were black.

Robert Coffman left St. Luke in February, 1975, to pastor Faith Church in Baltimore, Maryland. Dawson Tunnell was the next pastor at St. Luke from September, 1975, to December 31, 1978.

John Evans served as interim pastor after Dawson Tunnell left. Dr. Charles Hunter served as St. Luke's only Associate Pastor from May 11, 1969, to December 31, 1979.

The first African/American pastor, Curtis Jones, served St. Luke from July 12, 1981, to December 21, 1986. Under his leadership membership reached a high of about 317. David Pittinger and Jimmy Brown served as interim pastors after Curtis Jones' departure.

Isaiah and Devia Phinisee came to St. Luke as pastors in March, 1989, as a joint call for St. Luke and Glendale Presbyterian Churches. In 1992 the relationship with Glendale was dissolved and the Phinisee's became Co-pastors of St. Luke. Under the Phinisee's leadership, St. Luke began its first after school program and a summer enrichment program. These programs were designed to serve the entire community. A Youth Community Choir, made up of youth from St. Luke and youth from the community, was organized and sang on the fourth Sunday of each month. By the end of 1992, St. Luke had a total active membership of 142 and inactive members of 38. The Phinisees left St. Luke in June 30, 2000.

Rev. Kasonga Wa Kasonga was called to the pulpit in 2011 and served until 2013.

Pulpit Supply assigned by Grace Presbytery after 2013 included Ronald Lawrence; Jane Brumbelow, Rev Wesley Geary and Mary Stuart-Hall. Guest Ministers who were constant at different periods and were in the pulpit at least 90 days were Rev. Myron Hardy; Rev. Wesley Geary; Rev. Derrick Jefferson and Rev Peggy Rounseville.

St Luke Presbyterian Church had a long history of rich worship experiences, fellowship for all ages and strong service. Sunday Worship thrived under the leadership of Installed Pastors and

Pulpit Supply. Christmas Vespers was always a time for the local community to come and join in worship with members.

In addition to the After-School Programs that offered tutoring as well as a safe space for young people and the Summer Enrichment Program mentioned above, the youth of St Luke were shepherded by a week-long Vacation Bible school as well as participating in the National Black Presbyterian Youth Caucus. Each week of the Christmas holidays as well as the week after school ended, the youth of St Luke would also volunteer in local nursing homes helping with personal hygiene needs as well as spending time with residents and developing friendships.

St Luke also had an active Presbyterian Women's group that would host a Valentine's Gala every year where the community would be invited to dress up and come to enjoy a meal and fellowship with other couples. Presbyterian Women also sponsored an annual Angel Tree in cooperation with the Dallas Morning News.

Mission included hosting the Do-Mei Adventurers Club and Camp Fire Girls. An annual Health Fair was established to provide health screenings for local residents. Annual school supply drives provided for the needs of the three Elementary Schools in the surrounding neighborhoods. Their final mission ministry, the Oak Cliff Veggie Project, was started with a grant from Grace Presbytery and has grown into its own non-profit organization that provides education, cultivation, and home-grown vegetables twice a month for hundreds of local residents.

## **Report from the Congregational Support Committee**

- A. The Disaster Response Team (DRT) of Grace Presbytery is excited to announce two new ministries.
- B. Regional Church Safety Trainings: DRT will provide certified ALICE (Alert, Lockdown, Inform, Counter, Evacuate) violent threat response training courses with considerations for the church setting including worship in a sanctuary throughout presbytery regions. Response during a small group activity such as Sunday School, committee meeting, or Bible study/prayer meeting will also be specifically addressed. The final aspect of the informative training is an overview of safety team/policy functioning and a snapshot of information/assistance the DRT can provide to empower congregations in determining a path forward regarding church safety. All of this will be followed by a Q&A session to round out the experience for those attending. Participants will spend up to 6 hours learning

the ALICE methodology, discussing topics involved with church safety, participating in practical exercises, and enjoying a lunch where you can engage with fellow participants.

C. Church Safety Consultation/Training: DRT members who are ALICE certified instructors will be able to come to your church and **provide consultation/training in church safety**. This training will consist of assessing your church for potential issues, recognizing threats and dangerous situations, and responding appropriately to threats through active shooter training. There is **no fee to your church** for this training.

#### **Statement of Faith:**

As Euthyphro says to Socrates, ideas of the holy "dance around" and do not stay nailed in place. In the way my faith and its articulation have changed and will continue to change, I say proudly that I am both reformed and always being reformed. I believe the Reformed tradition understands if not celebrates this fact—that the holy can dance around. Nevertheless, a sense of God's call to a ministry of love and grace has persisted with me.

## DEEP ELLUM

The center of the African American community as a merchandise, business, medical and entertainment district. Known notably for the music of such artists as Huddie Ledbelly and Blind Lemmon Jefferson

## JUANITA CRAFT HOUSE

Mrs. Craft was an activist and politician who became the first African American woman to vote in Dallas County

#### HISTORIC SOUTH BOULEVARD

Started out as a Jewish neighborhood, but in the 1950s it became the homes of many prominent African American leaders of Dallas





# THE STORY

## **Meeting Cancellation Policy**

If a meeting needs to be cancelled or delayed for any reason, it will be announced on the Grace Presbytery website (<u>www.gracepresbytery.org</u>). Also, the outgoing voice mail message for the Grace Presbytery main phone number (214-630-4502 or 800-678-4502) will provide up-to-date information about meeting cancellation or delayed start times.

The decision to cancel or delay the start of a presbytery meeting will be at the discretion of the Moderator of the Presbytery, in consultation with the General Presbyter and Stated Clerk of the Presbytery. Rescheduling a cancelled meeting of the Presbytery is the responsibility of the Moderator of the Presbytery.

## **Parliamentary Procedure**

Parliamentary procedure enables the presbytery to become a deliberative assembly, to seek the will of God and to witness to our faith in Jesus Christ. It is never an end in itself. Parliamentary gamesmanship is never appropriate.

The will of the majority shall prevail, but the rights of the minority shall always be protected. Parliamentary principles balance individual conscience with the will of the majority. It takes seriously the following rights of individual members: (1) the right to know (due notice); (2) the right to speak (rules of debate); (3) the right to vote (membership); and (4) the right to hold office (fair representation).

The Moderator represents the unity of the body. The Moderator preserves decorum and protects the rights listed above.

If you wish to speak, stand, and move to a microphone (if you are a commissioner participating in person). If you are a commissioner participating remotely, use the computer program to ask to be recognized. The moderator must recognize all speakers before they can speak.

Parliamentary procedure allows discussion of a subject only when a motion about that subject has been made. To speak during the meeting, please ask to be recognized. When recognized by the Moderator, state your name, church, city, and status – such as ruling elder or Honorably Retired. You may speak to a pending motion or ask a question. The person making a motion will have first opportunity to speak to the motion. Only motions coming from individuals need a second. A motion made on behalf of a committee already has a second: the majority vote of the committee.

Only commissioners may speak and vote on motions. You should speak only once on a subject, but you may seek to speak a second time only after everyone who wishes to speak has spoken. All remarks during debate shall be addressed to the Moderator. Questions seeking information from a person who has the floor shall be addressed to the Moderator. Speeches to an individual or the whole presbytery are not permitted during debate. Reading reports or documents out loud requires the permission of the presbytery. In debate, remarks shall be confined to the pending motion. Remarks shall not impugn another commissioner or that person's motives.

Commissioners' names shall not be used.

To end debate, a commissioner must seek to be recognized, when recognized by the Moderator, state: "I move the previous question." It is not appropriate to call the question without being recognized.

If you offer a substitute motion or a new item of business, you should give the Stated Clerk advance notice and a written copy via email or hand delivered note. (An electronic copy is preferred. This help the Moderator and Stated Clerk facilitate the work of presbytery. The Stated Clerk is available to help you with suggestions as to how and when it would be appropriate to make the motion. The Stated Clerk and the Moderator are available to advise commissioners on the wording of any motion so that it can clearly express the concerns of the commissioner. When in doubt, ask. The Moderator and the Stated Clerk are eager to help you understand and use the process.

# **Persons Entitled to Vote**

- 1. All ministers of Word and Sacrament on the Teaching Elder Roll of Grace Presbytery.
- 2. All ruling elders elected by sessions in accordance with the formula approved by Grace Presbytery and the Standing Rules. (Questions concerning the number of elders permitted for each congregation should be directed to the Stated Clerk.)
- 3. Certified Christian Educators who are ruling elders but are not otherwise commissioned by their sessions during the term of service in an educational ministry under the jurisdiction of the presbytery.
- 4. Certified Associate Christian Educators who are ruling elders but are not otherwise commissioned by their sessions during the term of service in an educational ministry under the jurisdiction of the presbytery.
- 5. Ruling elders, not elected by their sessions, who are serving as elected members on these Presbytery entities: Presbytery Council, Committee on Ministry, Committee on Preparation for Ministry, Permanent Judicial Commission, Committee on Representation, Nominating Committee, Administrative Commission on Property, Board of Trustees, Personnel Committee, Budget and Finance Committee, Youth Ministry Committee, Young Adult Ministry Committee, New Church Development Committee, Congregational Support Committee, and Administrative Commissions.
- 6. Ruling elder commissioners to the last General Assembly.
- 7. Commissioned Pastors not otherwise elected from their sessions.

## Persons Entitled to Speak but Not Vote

- 1. Christian educators employed by churches of Grace Presbytery who are not certified and are not ruling elders.
- 2. Ruling elders elected from a new church development Steering Committee of Grace Presbytery.
- 3. Corresponding members (ministers of Word and Sacraments and ruling elders from other presbyteries or denominations) when received by the presbytery.
- 4. Representatives elected by the congregations of churches in covenant relationship with Grace Presbytery when approved by the presbytery.
